ADDITIONS/DELETIONS: 1. None.

PUBLIC COMMENT: 2. Brooke Fleuette, MCHS librarian spoke regarding the ALA Statement. She specifically checks to obtain appropriate in our library. Erik Johnson addressed his concern for censorship. Michael Reick opposes the State of Illinois deciding which books will be in our school libraries. David Russell is concerned for book censorship and Josh Frieden voiced his concern regarding keeping the control of book choices local. Natalie Nelson, MCJH Special Ed. teacher spoke regarding her students use of audiobooks.

BOARD COMMENTS: 3. None.

CORRESPONDENCE: 4. None.

COMMITTEE REPORTS: 5. Bray Builders met with the Building and Grounds Committee and discussed the three phases for MCHS. A Community Forum has been scheduled for 6:00 p.m. Wednesday, January 17, 2024 followed by the regular board meeting.

2023 TAX LEVY 6. Mr. Petrie stated the tax rate will remain the same as last year at 4.84. The bulk is in bond levy.

ADOPT PRESS POLICY UPDATES 7. Mr. Petrie stated that initially he was unsure about approving 7270, but after speaking with Nurse Becky Hyett, he believes 7270 should be approved with no issues. Julie Wagner spoke regarding ALA Bill of Rights. Her understanding is that it is up to the librarian to obtain appropriate books available for the students. Though Brooke Fleuette's choices in student books are highly regarded, Julie fears that by adopting 6320, our ability to remove books that are sexually explicit will not be in the district's control. She believes the American Library Association doesn't have our local students' best interests in mind. Julie Wagner requested the board delay a decision regarding PRESS policy update 6230 and opposes sexually explicit books for students. Bill Smock stated that we have policies in our district where parents are able to view what books are available to their children. Each year at registration, parents are given the option to sign a waiver which does not grant their children access to the interlibrary book loan system. Of the 6,000+ online books available via interlibrary loan, it is up to the parents to discuss appropriate books with their children.

ADDITION OF MCHS FY25 SCIENCE TEACHER 8. Mrs. Cooper stated the need for an additional MCHS science teacher. Currently, some science courses are currently offered on rotation every other year. It would also allow honors courses for freshman and sophomore classes and adhere to the advanced placement act requirements.

STUDENT ATHLETIC ADMISSIONS 9. Mr. Petrie stated not enough revenue is made at school athletic events. It is recommended to eliminate the \$1 student admission fee and the Board will monitor the fee if an issue arrives.

FOIA REQUESTS: 10. Mr. Petrie addressed the recent FOIA requests regarding purchasing records, literacy and IAQ and Environmental Testing.

SCHOOL BOARD CONVENTION: 11. In addition to their written report, board members shared their IASB joint conference experiences. Julie Wagner shared the "Carousel of Panels". She believes it is worthy to look into adopting in our district. It incorporates great community involvement as another method to reach out to the community especially since our community is an older generation. Bill Smock shared "Amplifying Student Voices" where a district added two students to their board meetings. Jason Monson will share his report in the future.

ADMINISTRATIVE REPORTS: 12. In addition to their written reports, the principals added the following:

Tim Sedam stated that Mr. Fornoff has the students learning how to play chess. Teresa Ibouhouten added that the New Boston Elementary Winter program went well and Amplify reading scores are up.
