5. Jake Frieden and Mr. Petrie went over the Finance Committee Meeting Minutes, discussing the health insurance balance increase compared to last month.

Bill Smock reviewed the Buildings and Grounds Meeting Minutes discussing the possibility to hire a company to conduct a facility plan. He discussed the handouts in the board packet from BLDD Architects.

TAX LEVY

6. No changes were made from the tentative Tax Levy presented last month. We are not abating Tax Levy on bonds for next year. Using those funds for facility upgrades/construction. Final rate is 4.85 prior to bond and interest.

JUNIOR HIGH SOFTBALL

7. The board discussed the addition of the softball program at the Junior High. Transportation, multiple sports, and the fall season was a concern. Many positives were also discussed prior to taking action.

8. We responded to one FOIA request from SmartProcure.

21st CENTURY GRANT

9. Mrs. Day discussed the 21st Century Grant Program at the High School. Lindsey Beighle is our site coordinator and organizes the before and after school activities that are offered to our high school students. The library is open Monday-Thursday until 5:00pm offering crafts, homework help, games, etc. Our students also have the opportunity to come before school for homework help. Two family paint nights have been a great success. The program has also purchased books for book studies along with many other items.

ROTARY CLUB GRANT AWARD

10. Mr. Petrie shared the exciting news regarding a grant that the Elementary Schools received from the Rotary Club. All Kindergarten – 2^{nd} Grade Teachers and Title I have \$150 to spend on books for their classrooms, totally \$2,550.

PRESS PLUS

11. Mr. Petrie discussed the cost and benefits of upgrading to IASB's PRESS Plus Service. This policy update service provides full access to PRESS online, provides additional assistance to help districts keep their policy manuals current, and is customized to fit our district's needs. Brochures were included in the board packet. More information will be gathered for the next board meeting.

STAKEHOLDER'S MEETING

12. Mr. Petrie highlighted some of the information from the Stakeholder's Meeting minutes. Technology reported that we are now one to one with Chromebooks in grades 2-12.

REPORT ON GOALS CHROMEBOOKS

13. Mr. Fleuette and Mr. Bush reported how Chromebooks are utilized in their buildings. They give the students the ability to individually reach their particular levels, once general instruction is finished. Chromebooks also help teachers to develop plans for individual students, showing both strengths and weaknesses. Administrators feel they have been a wonderful addition to the curriculum and our students.

ADMINISTRATIVE REPORTS

14. In addition to their written reports, the principals added the following:

Apollo – Mr. Fleuette discussed the Apollo Elementary state report card. The Apollo Christmas Program was live streamed on facebook. The kids did a great job. He also mentioned the Warrior Calvin Mural that Hannah Baker, and Myah Balmer helped our students create.

New Boston – Mr. Bush discussed the New Boston Elementary state report card. Mr. and Mrs. Bambrick read "The Giving Tree" to our kindergarten students and each child received a book of their own to take home.

MCIS- Mr. Koresko discussed the Intermediate School state report card. He also commended the music programming stating 70% of MCIS students participate in band and choir.

JH – Mr. Sedam was not in attendance.

HS - Mrs. Day discussed the High School state report card. She also mentioned the PA system. Phones are in place in each classroom. They will begin using the phones 2^{nd} semester.
