2022 TAX LEVY

6. Minor changes were made from the tentative Tax Levy presented last month due to updated numbers. 10.9% increase from last year due to the increase in EAV in our area. The tax rate remained the same from last year at 4.84.

FY22 AUDIT

7. Mr. Petrie gave a brief summary of the audit. 532 days cash on hand due to bond revenues. Segregation of duties continues to be our one finding. This is common among small school districts. The district does take precautions by hiring an independent treasurer. Our profile score declined from 4.00 to 3.80 due to increased borrowing, but still remains in the highest category.

MCJH SCHOOL IMPROVEMENT PLAN 8. Mr. Petrie discussed the changes to the MCJH School Improvement Plan. Due to the change in grade configuration at the Junior High and the FY23 grant funding it was required to revise and approve the plan.
