DISTRICT GOALS UPDATE 7. Mr. Petrie reviewed the district goals in place for this school year and provided updates. K-8 is piloting new K-8 math programs for adoption in 2023. Making gains in math scores. Seesaw has been adopted by the PreK program for communication purposes. Google Classroom continues to be utilized by all levels. STEM classroom at NBE with addition of Math Interventionist Sam Duncan. We continue to expand involvement in our schools working closely with Mercer County Health Department, City of

Aledo, MC Crisis Center, Mercer County Historical Society, etc.

Communication with the community and parents most recent notifications using our new all call system/email: 5 essentials survey, Community Forum Invites, testing dates at various buildings, and field trips. Mr. Petrie and Doug Giles met with Philips and Associates to discuss the 10-year life safety report and what projects are left to complete. The addition of a SRO

at New Boston Elementary was implemented this year.

and the admins will work together to write new district goals and objectives for the 2023-2024 school year. Invitations were emailed on Tuesday.

#### TRAC UPDATE

9. Mrs. Cooper discussed the information that was provided in the board packet, including the invitation to join the TRAC, our response, and the proposed football, volleyball, and basketball schedules. Many unknowns with this conference at this point. The board asked Mrs. Cooper to put together a google document listing pros and cons of joining this conference. She will reach out to coaches and athletic directors as well.

# ADMINISTRATIVE REPORTS

10. In addition to the written reports, the following was mentioned:

Mr. Fleuette shared a picture of the new front entrance decal that was added at Apollo Elementary. The one way window film provides some additional safety at the entrance.

Bill Smock had questions regarding lack of space in most buildings. This is primarily due to the additional services we have added, including but not limited to, expanding course offerings at the high school, additional counselors, SROs, Math Interventionists, Math and Reading Coaches, Nurses in all buildings, and Social Workers.

Mike Bowns discussed the playground area at New Boston Elementary. The City of New Boston has offered to dismantle, store, and rebuild the newest playground equipment.
